REGULAR MEETING

September 13, 1954

The Durham Kennel Club, Inc. held its regular monthly meeting at the country cottage of Mr. and Mrs. David Scanlon, Jr. This meeting was centered around the twenty-eight young people present as guests of the Club, to introduce the purposes and activities of the Club. Before the meeting was called to order a picnic supper was served.

The meeting was called to order by Mrs. Charles Moore, president.

The treasurer's report was given showing cash on hand last report, \$809.32, receipts \$128.18. Disbursements \$120.29, leaving balance on hand \$817.21. Report approved.

The election of Club secretary was then called for. The Board of Directors named Mrs. Herbert O. Sieker be recommended. There were no further nominations from the floor.

Mrs. Cuyler made motion that Mrs. Sieker be elected secretary.

Mrs. Scanlon seconded. Approved.

Mrs. Moore then asked Mr. C. P. Jones to report on the Carolina Kennel Club Ass'n. meeting, which he attended as a delegate from the Durham Kennel Club, Inc. Mr. Jones asked to have this report read at another time.

The Club Bulletin was then discussed. Since it is to be a regular monthly edition it was decided the Club help meet expenses. The amount of \$50.00 seemed adequate.

Dean Cox motioned the amount be given Miss Rhine, editor, to run the paper.

Mr. E. E. Morris seconded. Motion approved.

At the Board Meeting held August 24th, Dr. Kamin, program chairman, asked that he be given a specific amount of money to be used for planning programs. The board elected to grant \$100.00 for this purpose. Mrs. Moore asked that a motion be made to approve this amount.

Mrs. Keplar made the motion.  
Dean Cox seconded.

This was followed by a discussion by Mr. Robt. Block, to have the president define more clearly how the money should be spent.

Mrs. Moore explained the sum of \$100.00 was to be used for the Club programs for '54-'55, ending with the last meeting in May. That Dr. Kamin could use this money for such purposes as renting movies, paying speakers, etc. There is to be no said amount spent for each meeting and any money remaining unused after the last meeting in

May be returned to the treasurer. No further discussion was called for. Motion approved.

Mr. Charles Moore, treasurer, then asked the Club's approval to cover costs of drinks, paper plates, etc., used for this meeting. The amount being approximately \$7.00. The Club approved.

The meeting as then turned over to Mr. & Mrs. Reginald Keplar.

Mrs. Keplar gave a short discussion on Obedience training. Mr. Keplar assisted by Jimmy Williams and his Chesapeake Bay Retriever "Cindy", demonstrated what Obedience training teaches the dog and and his master.

Dean Cox then welcomed the young people and explained briefly, the activities and aims of the Durham Kennel Club. An invitation was extended to all those invited to this meeting to attend the next regular Club meeting, October 4th, at Forest Hills Club House.

Mrs. Hoenig gave her report on the progress of the Sanction Match to be held October 26th and offered to hold a class on Sunday the 19th, to instruct all new comers in handling and grooming their dogs for the show.
