The Durham Kennel Club held its monthly meeting on April 21, 1969, at the Little Acorn Restaurant with thirty members present. Following a very interesting program by Mrs. Dorothy Bullock, "Obedience: Past, Present and Future," Dr. Grimson called the meeting to order. Minutes of the February meeting were approved as read.

Miss Margaret Norman reported that the Show had cleared \$1,710.04 with \$100.00 still outstanding from Moss and that there had been \$486.71 profited from the three obedience classes for this fiscal year.

Applications for membership were read and approved into the Kennel Club as follows: John B. Cahoon, Bryant O. Dulap, Jr., Suzanne Farrell, Dr. Duncan M. Getsinger, Mr. and Mrs. Robert H. Sibbs, Mr. Jon G. Gitelson, Mr. and Mrs. Sam W. Gray, Jr., Tracy T. Hackney, Mrs. Dorothy H. Hatley, Mr. Charles E. King, Mr. and Mrs. L. Briggs Neal, III.

Mrs. Vivian Haines reported that there had been around 200 additional entries for the Spring Show in March.

Dr. Grimson reminded the Club that the recommendation for the changes in the by-laws for the membership dues had been proposed to A.K.C., would be voted on at the May meeting, but would not go into effect until January 1970. Also at the May meeting, the new officers will be elected and voted upon.

Dr. Grimson then reported on the actions taken at the Board Meeting held on April 16 as follows:

- (1) Recommendation was made that the entry fee for the annual sanctioned match be increased from \$1.00 to \$1.50 per dog.
- (2) Recommendation that he representatives to the Tarheel Circuit propose that there be
 - a. a 1,000 dog entry limit set
 - an increase in the entry fees for each match in the Circuit

The meeting was then turned over to Mr. Bill Heriford, Chairman of the Budget Committee to explain the proposed budget for 1970 and a copy of this was give to each present for consideration along with the proposed recommendations voted on at the Board Meeting. A motion was made that wording of the proposed recommendation regarding the honoraria for obedience instructors be changed to read: 'That the honoraria for obedience instructors be paid at the rate of \$25.00 token fee per instructor or assistant instructor per the twelve week class, less \$2.00 per class session missed.' After discussion, motion was made, seonded and passed to this effect. Motion was then made, seconded and carried that the proposed budget with the other recommendations be accepted as presented.

The meeting was adjourned.
