GENERAL MEETING

MAY 21, 1983

It was moved by Bill Nelson, and seconded by Joyce McHenry, that this fund be donated to the NC School of Veterinary Medicine. The secretary was asked to so advise the DVM School and to request their input of on-going research so that a specific item could be selected by the club memebers.

Joyce McHenry asked consideration for the purchase of a weed eater/wacker and, in stating her agreement, President Marge White stated that the high grass around the clubhouse needed to be cut. It was discussed whether to do it now or to wait until just prior to the planned August match show. It was estimated that the weed wacker would cost about \$120 and the expenditure of approximately this amount was moved and seconded and Joyce McHenry was asked to make the purchase.
