

MINUTES FROM DKC MEMBERSHIP MEETING:

October 17, 1994

Ken Killinger still needs help moving tables, chairs, etc. from the building to the fall show site on Friday p.m. and returning them to the building following the show.


Jeanne Simmons Clayton reported for the eye clinic--it is well staffed, but there may still be a need for additional volunteers.
