Old Business

Sally Ridge: The Memory Walk behind the building would be built for \$7438. It is proposed to be a 40 ft. long, 4 ft. wide brick path with a small patio at the end. Profits earned from brick sales will be used to offset this expense. The bricks are being sold to members until July 15, 2015. Those bricks will be used in the initial construction of the walkway. After then, bricks sold throughout the year will be installed annually by the landscaper. He has agreed to return once a year and place up to 100 bricks at a cost of \$420. If we sell 10 bricks a year, the profits will cover his cost. The construction should begin mid to late August to allow for bricks to be engraved and delivered. There was discussion about whether the walkway would be built if 100 bricks weren't sold by July 15. There was also a question about impervious surface (answered by George Beglane): it is not an issue because Durham Kennel Club has well over 63,000 square feet of usage, and this project will use less than 1%.

Bob Wisniewski moved to authorize \$7,500 to build the memory walk. Seconded and approved.
