Minutes from the May 18, 2015 meeting. Approved.

President's Report (Ann Carter):

We have been busy since we last met. Have you seen the new kitchen? Many, many thanks to Kim Tyndall and Linda Wozniak, with Tommy Wood's, Joyce McHenry's and some spouses' help. They single handedly did this and it is a great job. Cathy Wells and I gave it a good cleaning. We removed all dog equipment, targets, etc. from the kitchen as there are plenty of other places they can go and now that it is renovated and cleaned, we hope you will support a "no dog" policy in the kitchen.

Special thanks also to Lynn Reagan Hull for sanding, priming, and painting the outside doors. That was a huge job that was much needed.

Tommy Wood is our new Building Maintenance chair and he has been busy! To name a few of the things he has done: He installed new door closers so they don't slam, filed the latches on outside doors so they are easier to lock, installed a mailbox in the kitchen so you can leave checks and receipts, installed new fire extinguishers, put sleeves on the fluorescent lights in the kitchen, rehung the signs, taped the loose insulation, and put poles on the driveway at culverts. This was along with the regular maintenance, changing light bulbs, filters, cleaning the gutters, etc.

As you might have noticed, we are making preparations to paint the inside of the building since it has not been painted in over 10 years. Before painting can begin, we needed to patch holes in the walls, put in additional chair rails to accommodate the higher backs of the white chairs, and put up trim at the loft above the kitchen window. Tommy & Phyllis, Roger & Nancy and I have been doing all of this. You too can join the fun. Plans are to put up a 1 x 3 rail across the mirrored and backside of the building to keep the jumps from banging the walls. We are talking about extending the wide board to the end and hanging all the plaques together, centered on the wall. We would like your input and help ... and your patience while we continue to make these preparations, as the club will look a little disheveled for a little while. October 24-25, 2015 will be the actual work weekend. I hope you will consider coming out to help that weekend.

Some color choice swatches will be painted in the far corner. We would love to hear which one you like. We formed a new committee, the "Aesthetics committee." This committee will help oversee "all things beautiful" at the club, inside and out. If you would like to be a part of that committee, or would like to share your opinions please contact Sally Ridge.

Committee chairs and their contact information are listed on the website.

We discovered we had a large tree on the right side of the building that was rotten in the middle and leaning towards the building. With summer storms becoming so regular, we decided it needed to be taken down immediately. The tree in the middle is not looking good either, so in an effort to save it, we are going to have an arborist come out and look at it.

Another committee we added is an Ethics Advisory Committee (the name may change). This five-member committee will consist of AKC judges. When the committee receives a formal complaint, the committee will first ask "If proven to be true, does this reflect badly on the club?" If the answer is yes, they will pursue it and give their recommendations to the board. What better members than the ones that have the expertise of the AKC Rules of Misconduct? Jack Sappenfield will chair the committee.

In addition we are organizing a board liaison program, at least to the major committees. This is a way to keep the information and communication flowing between the Board and the committees in an informal way.

On June 1st we implemented the Building Access program. We are still tweaking it a bit as you can expect with any new program. Except for a few people that are forgetting the rules (see the website for reference) I think people like and appreciate the opportunity to work their dogs more often at times that are convenient to them. The Board approved the following changes to the requirements for access to the building:

- (1) Eliminate the requirement for meeting attendance
- (2) Change the definition of "service activity" to 8 hours (annual) of service that benefits the club and can be verified.

We know that our septic system is old and may fail at any time. The average life expectancy in 30 years in Durham County and ours is 40 years old. We are having it emptied every 6 months now, just before major events when it is most used. We are taking the proactive route and will not have to scramble if it suddenly fails, are working with the Durham Health Dept., and are getting a quote on a system so we will be prepared and ready to replace it in short order.

We have made sure the kitchen is up to code and will improve the drain when the new septic system is installed.

After getting clarification from the Division of Public Health – Protection and Facilities Department of exemption from inspections for the statute for non-profits, we have had to

make some minor changes to comply. The policy states that we can serve food where a profit is made, two days out of the month. We have been doing three at our three-day agility trial.

As President, one of my goals is to get what we have in good working order and I think we have made a lot progress and are well underway. I feel then, and only then, can we seriously talk about expansion, etc. – whatever the membership wants. We will still have some major expenses coming. Besides the new septic system, we will probably need a new air conditioner unit/s and the roof will need to be repainted in two years. Currently our finances are in good shape and we are planning for those improvements.

We are in the very initial stages of putting together a long-range committee who would first gather the ideas of members as to what your wish list would be as a starting point. Anyone interested in helping with that, please let me know. We really do want to do what You, the members, want. Thank you.
