### **NOTICE TO EXIBITORS**

---

- Due to limited space, no unentered dogs will be allowed in the building.
- Exhibitors will be responsible for cleaning up after their dogs and themselves in and around the building and parking area.
- Food will be available on the days of the trials for a nominal charge.
- Dogs cannot be left in the building overnight.
- Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made.
- Bitches in season: Bitches that come in season after the closing date of the rally/obedience trial may have all but \$10.00 of the entry fee refunded upon receipt by the trial secretary of a veterinarian certificate prior to the beginning hour of judging.
